
HARE KRISHNA MOVEMENT IS BONA FIDE RELIGION

Washington, March 18


The Hare Krishns m ovement was called a "bons fide religiou" yesterday by the New York High Court Justice who threw out two charges against the officials of the movement of "fillegal imprisonmentil and "initempted extertion." The charge had been preferred by an angry parent that his son, as well as another disciple, had been held by the movement illegally and that they had been brainwashed. "The entire and basic issue before the court." said the Justice in dismissing the charges. "Is whether the two alleged victims in this case and the defendants will be allowed to practice the religion of their choice and this must be answered with a resounding affirmative." Said Mr Justice John Leaby, "the Mark Krishna movement is a bona fide-religion with roots in India that go bark thousands of years. It behoowd Mcrril Kreshower and Edward Shapiro to follow the tenets of that faith and their inalienable right to do so will not be trampled upon. The separation of church and state must be maintained. We must remain a nation of laws, not of man. The presentment and indictment by the Grand Jury was in direct and blatant violation of the defendant's constitutional rights" The Justice said that it appeared to the court, "The people rest their case on an erroncous minor premise to arrive at a fallecious conclusion. The record is devoid of any specific allegation of a misrepresentation or any art of deception on the part of any deleti dant" The Justice said, "The freedom of religion is not to be abridged because it is unconventional in beliefs and practices or because it approved or disapproved by the mainstream of society or more con-ventional religions. Without this proliferation and freedom to follow the dictates of one's own conscience in this search of approach to God,




